TERMS AND CONDITIONS

Rates are as posted. Charges are for the use of the assigned site, hook up for sewer/water/electricity only and use of the general RV Park area. The site is for personal vacation purposes only by the registered guest who is staying at the park themselves. NO Air BnB nor any other commercial, business nor any other rental activities are NOT allowed by any customers or others to operate in the RV Park. The RV Park assumes no responsibility for loss through fire, theft, collision or otherwise to the RV, Tent, car, any trailers or their contents, whether due to negligence or otherwise. Use of the RV Park and equipment is for yourself, your family and your guests, and any others is solely at your own risk and subject to the RV Park Rules, receipt of a true copy of which is hereby acknowledged. The RV Park, its employees, servants, agents or contractors shall be saved harmless from any claims whether in contract or by lawful tort, by or on behalf of all those admitted to the Campground pursuant or because of this agreement. In addition to the set charges, any taxes levied on the RV/Tent, any ancillary structures and the rates charged shall be paid on registration or as may be otherwise required. The signatory, as signed below, represents and warrants that he/she is responsible for and signing on behalf of his/her family, guests and any other persons accessing the Campground with his/her family, guests and any other persons accessing the Campground with his/her permission or knowledge. Any violation of this agreement, the determination of which shall be in the sole discretion of the RV Park Management/Operator, shall result in termination of this agreement. Upon termination, the camper, his/her family and guests shall be deemed to be trespassers, under the Trespass to Property Act, and the RV Park Management/Operator is hereby appointed the RV Park agent for disconnecting services and removal of their RV/Tent, Car and other structures and equipment.

In consideration of renting a recreational site at Nature’s Inn Dryden RV Park I (we) agree:

- That there is no lifeguard on duty – swimming is not allowed from any docks or other structures located in the RV Park and/or along the shoreline in the RV Park area. Any lake swimming accessed from the RV Park is entirely at your own assumed risk.
- Any and all children must be accompanied by an adult while at or in the lake area. There is no access allowed on the dock areas at any times.
- The RV Park is not responsible for any pets/dogs that enter the lake water and/or are on the RV Park property and assumes no responsibility for any loss/harm/accidents whether by/in the lake and/or on the RV Park Property. Owners are totally responsible for their pets at all times.
- That all pets/dogs will be on a leash at all times, under the control of the owner at all times, will not disrupt other guests in any way at any times – including barking. That any pet/dog feces will be immediately picked up by their owner and deposited into their own trash at their RV. Failure to look after your pet in all ways above - may result in termination of your stay and being asked to leave the RV Park.
- I understand that the RV Park is conveniently located within the City of Dryden close to amenities where the general public accesses and there may be some noise that arises from this which is not under the control of Nature’s Inn Dryden RV Park.
- COVID Safety Protocols will in place where appropriate, and washroom/shower use is for a limited number of Tent Sites and those without Sewer/Water hook-ups in their RV. If your RV has Sewer/Water hook-ups – you must use your own facilities.

WAIVER AND RELEASE OF LIABILITY

I hereby assume all risks and dangers to myself, anyone in my group, any pets and all responsibility for any losses and/or damages, whether caused in whole or in part by negligence or other conduct of the owners, officers, employees, agents or contractors of Nature’s Inn Dryden RV Park or any other person.

I, on behalf of myself, my personal representatives and my heirs, hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify Nature’s Inn Dryden RV Park and its owners, agents, directors, officers, employees and contractors from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of service or otherwise which may arise. I specifically understand that I am releasing, discharging, and waiving any claims or actions that I may have presently or in the future for negligent acts or other conduct by the owners, agents, directors, officers, contractors and employees of Nature’s Inn Dryden RV Park.

RATES AND REFUND POLICY:

All stays must be paid in full upon arrival at the park. You must register your information, read all of the Terms and Conditions, sign the registration form that you have done so and that you and your camping group will follow them. Management must approve your stay and your site allocation and you must pre-pay your stay before you park your RV/Tent and other vehicles.

THERE ARE NO REFUNDS ONCE YOU HAVE REGISTERED, PAID AND PARKED YOUR RV/TENT. You have committed to taking this site for this time period– while others will have been denied a booking for this time frame you have requested.

Washroom/Shower are only for a limited number of Tenting guests or those without Sewer/Water hook-ups in their RV.

RV PARK HOURS ARE 9 AM TO 9 PM DAILY. ALL CAMPERS MUST BE REGISTERED, PAID AND PARKED BY 9 PM FOR THE COMFORT AND QUIET OF ALL RV PARK CUSTOMERS AND IN RESPECT FOR THE RV PARK MANAGEMENT. IF YOU ARRIVE LATER THAN BETWEEN 8:30 – 9:00 PM – YOU MAY NOT BE ADMITTED TO THE RV PARK THAT NIGHT.
